i. \$15 Minimum Wage

- 1. Not sure if the city can implement or if it needs to pass at a federal level
- 2. Now is the time to write to our City office with how it affects our businesses

ii. Paid Sick Leave

- 1. 3rd attempt to pass in City Council. Past two times it was overturned by the Mayor. The Mayor is much more inclined to pass sick leave this time
- 2. The bill submitted by Councilman Greenlee is still in negotiations and is not the final bill.
- 3. Councilman Jones is supportive of the bill.

iii. Minority contracting with the city

- 1. Delay in payment from the city
- 2. Speak with Angela Dowd Burton regarding minority businesses

iv. BUO taxes

- 1. Issues for profits
- 2. How can we go after delinquent bills of businesses outside the area
 - a. A bill was passed by the State saying that we can go outside the city to seek repayment.
- v. Concerns of Businesses regarding aforementioned legislation:
 - 1. Often legislation forgets to take into account collective bargaining contracts.
 - 2. Concern that if bills passed businesses would move out of the city.
 - 3. Concern that current businesses would have to let go of employees.
 - 4. More qualified workers from outside the city would come into the city for jobs, it would make the job market even more competitive.

- 5. Josh Cohen will send specific aforementioned legislation to Sarah Cuzzolina who will forward it to BAWP members and meeting attendees.
